WHEREAS, a Verified Certificate of Amendment has been filed in the Office of the Commissioner of Banks and Trust Companies, showing action taken by the stockholders of LA CRANGE BANK & TRUST COMPANY, at 14 SOUTH LA CRANGE ROAD, LA CRANGE, County of COOK, and State of Illinois, amending its charter, to "provide that the bank's name be changed from LaCrange Bank & Trust Company to First Illinois Bank of LaCrange."
