CHARTER OF LA GRANGE BANK & TRUST COMPANY;

WHEREAS, A Verified Certificate of Amendment has been filed in the Office of the Commissioner of Banks and Trust Companies, showing action taken by the stockholders of LA GRANGE BANK & TRUST COMPANY, at 16 SOUTH LA GRANGE ROAD, LA GRANGE, County of COOK, and State of Illinois, amending its charter, to "provide that the bank's name be changed from LaGrange Bank & Trust Company to First Illinois Bank of LaGrange;"

AND WHEREAS, It appears from the evidence submitted to the Commissioner of Banks and Trust Companies that said action was taken in accordance with the provisions of Section 43 of an act of the General Assembly of the State of Illinois known as the "Illinois Banking Act", approved May 11, 1935, in force January 1, 1937, as amended, and

NOW, THEREFORE, I, WILLIAM C. HARRIS, Commissioner of Banks and Trust Companies, State of Illinois, by virtue of the powers vested in me by the act aforesaid, do hereby approve the act, and article 1, first paragraph, of said charter and the amendment thereto, effective upon filing for record this twentieth day of October,




