- 1. Grantors shall [1] promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in gent condition and repair, without waste, and free from mechanics or other liens or claims for lien not expressly subordinated to the lien hereof, (3) pay when due any indebtedness which may be secured by a lieu or charge on the premises superior to the lien hereof, and upon request exhibit astisfactory evidence of the discharge of such prior lien to Trustee or to Beneficiary, (4) complete within a responsible size any buildings on buildings now or at any time in process of erection upon said premises, (5) make no material alterations in said premises of the use thereof, (8) make no material alterations in said premises except as required by law or municipal ordinance.
