

ARTICLE FOUR

The initial number of directors to be elected shall be nine (9).

ARTICLE FIVE

The authorized capital represented by withdrawable capital shares which the association may issue shall be unlimited.

ARTICLE SIX

The date of the annual meeting of the members shall be on the fourth Wednesday of January.

ARTICLE SEVEN

The quorum required for action of the members (except as otherwise provided by law) is 33 1/3% of the total number of votes which all members of the association are entitled to cast.

ARTICLE EIGHT

The association may issue mutual capital certificates pursuant to the rules and regulations of the Federal Home Loan Bank Board (the "FHLBB"). Subject to such rules and regulations, the board of directors of the association is authorized without the prior approval of the members of the association and by resolution or resolutions from time to time adopted by the board of directors and approved by the FHLBB, to provide in supplementary sections hereto for the issuance of mutual capital certificates and to fix and state the voting powers, designations, preferences and relative, participating, optional or other special rights of the certificates and qualifications, limitations and restrictions thereon.

Members of the association shall not be entitled to pre-emptive rights with respect to the issuance of mutual capital certificates, nor shall holders of such certificates be entitled to pre-emptive rights with respect to any additional issues of mutual capital certificates.


WHEREAS, Security Savings and Loan Association has heretofore maintained a main business office in Decatur, Illinois and two facility offices at other locations in Illinois; and
