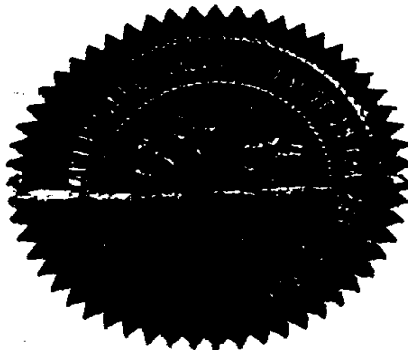
CONVERSION CERTIFICATE

WHEREAS, Riverside National Bank, the Converting Bank, located at 15 Riverside Road, in Riverside, County of Cook, State of Illinois, has filed with my Office, the necessary documents as prescribed under the provisions of "An Act of the General Assembly of the State of Illinois, known as the Illinois Banking Act," approved May 11, 1955, in force January 1, 1957, and acts amendatory thereto for the purpose of converting to a state bank.

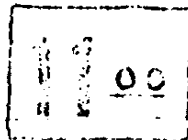

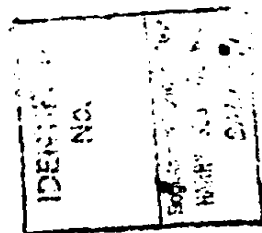
