This cause having come on to be heard upon the Petition for Dissolution of Marriage of the Petitioner, LEARLEE HUMPHERY, and the failure of the Respondent, ROBERT HUMPHERY, to appear or answer and an order of default having been entered against Respondent, ROBERT HUMPHERY, and the Court having heard the oral arguments of the witnesses sworn and examined in open court, having heard the arguments of counsel and being fully advised in the premises and in consideration thereof, FINDS:

1. That the Court has jurisdiction of the subject matter herein and the parties hereto.
2. That the Petitioner is now and for more than 90 days continuously and immediately preceding the filing of the Petition for Dissolution of Marriage has been a resident of the State of Illinois and is an actual resident of Cook County and any acts complained of therein were committed in Illinois.
3. That the parties were married on May 7, 1960, and said marriage was registered in Cook County, Illinois.
4. That no children were born of the marriage, the Petitioner is not now pregnant nor have any children been adopted by the parties.
5. That the Petitioner has proven her grounds for dissolution as herein alleged in the petition and the Respondent is guilty of repeated mental cruelty,


C. That the Petitioner hereby waives any and all right to maintenance and the Respondent is hereby barred from any and all right or claim to maintenance.

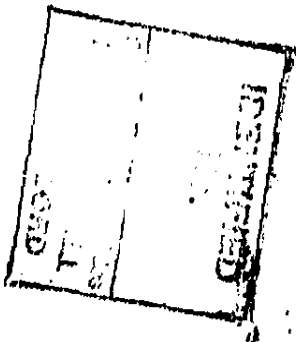
