THIS TRUST DEED, made June 17, 1987, between James E. Hutchins and Patricia A. Hutchins, his wife

herein referred to as "Mortgagors," and Edward P. Cromerius, of Palatine Cook County, Illinois, herein referred to as TRUSTEE, who attest that WHEREAS the Mortgagors are justly indebted to the legal holders of the Promissory Note (herein called "Note") hereinafter described, said legal holder or holders being herein referred to as Holders of the Note evidenced by one certain Promissory Note of the Mortgagors of even date herewith, made payable as stated therein and delivered, in and by which said Note the Mortgagors promise to pay an Amount Financed of Seventeen Thousand Six Hundred Thirteen and 49/100 (\$17,613.49) Dollars with interest thereon, payable in installments as follows: Three Hundred Eight and 13/100 (\$308.13) Dollars or more on the 22nd day of July, 1987, and Three Hundred Eight and 13/100 (\$308.13) Dollars or more on the same day of each month thereafter, except on the 22nd day of June, until said Agreement is fully paid and except that the final payment, if not sooner paid, shall be due on the 22nd day of June, 1987

NOW, THEREFORE, the Mortgagors to secure the payment of the said sum of money in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

The West 30 feet of Lot 12 in Block 10 in the Subdivision of part of the South 1/2 of the Northwest 1/4 of the Southwest 1/4 of Section 4, Township 39 North, Range 13, East of the Third Principal Meridian, as per plat recorded July 11, 1890, as Document Number 1,301,230 in Book 44 of Plats, Page 12, in Cook County, Illinois.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

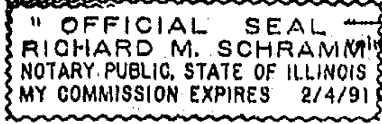
