Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds made. The Funds are pledged as additional security for the sums secured by Lender may agree in writing that interest shall be paid on the Funds. These items are called "escrow items." Lender may estimate the Funds due on the Pasis of future secrow items.

UMFORM COVENAUTS. Bottower and Lender covenant and Late Charges. Bottower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Mote.
