Pursuant to your request, I have secured a copy of the half sheet for the above referenced action. Please note the following:

1. On the front side of this half sheet, at the bottom of the page, a Judgment for \$945.34 plus costs was entered against us on February 24, 1981. This Judgment was entered because our attorneys failed to show up and this is called a "Judgment by Default";
2. On the reverse side of this same document, our attorneys presented a Motion on May 29, 1981 in order to have the Judgment vacated. This Motion was allowed, the Judgment vacated, and the case set for trial on October 30, 1981; and
3. On October 30, 1981 Judge Todd entered the following Order:

"Evidence of hearing after cause called for trial, plaintiff rests - Motion for defendant - verdict as to Irwin List - granted. Both sides rest, court finds for defendant and against plaintiff, Judgment for defendant."

The above half sheet has been certified by the Clerk of the Circuit Court on July 24, 1987 and sealed with his official seal. This certified document should serve as adequate proof in this particular instance in order to have your credit rating cleared. However, the Judgment is still on record with at least one credit bureau in Cook County. I am currently securing seven more copies of the certified half sheet to send to all seven credit bureaus to clear our good name.
