JOHN M. MUELLER, ("Affiant"), being first duly sworn, on oath deposes and says that:

- 1. Affiant is an attorney duly licensed to practice law in the State of Illinois.
- 2. Affiant is the attorney-at-law and agent for Betty Jane Higgins ("Grantor") and Kent R. Higgins ("Grantee"), grantor and grantee respectively in that certain quit claim deed dated August 16, 1985 ("Deed") conveying Grantor's interest in the following described property:

Lot 1479 in Rolling Meadows Unit No. 8, being a Subdivision in that part of the West Half of Section 36, Township 42 North, Range 10, East of the Third Principal Meridian, lying South of Kirchoff Poad in Cook County, Illinois, according to the plat thereof registered in the Office of Registrar of Titles of Cook County, Illinois on July 19, 1955, as Document No. 1608437

hereafter "Real Estace" and commonly known as 3104 Thrush Lane, Rolling Meadows, Illinois.

- 3. On August 16, 1985, Granton executed the Deed and shortly thereafter delivered it to Grantee, who thereupon delivered it to Affiant.
- 4. Affiant prepared the other documents necessary for filing the Deed with the Cook County Registrar of Titles.
- 5. Affiant then placed the Deed, the related documents and the Torrens Certificate in an office file related to the Grantee but unrelated to the transfer of the Real Estate, and placed the file in Affiant's office. The file which was at all times in Affiant's office, became unexpectedly inactive.
- 6. On September 14, 1987, Affiant's attention was again drawn to the file in which the documents were located and upon discovery, promptly took steps to file the documents with the Cook County Registrar of Titles.
- 7. This Affidavit is made for the purpose of inducing the Cook County Registrar of Titles to accept the Deed for filing at this time.
