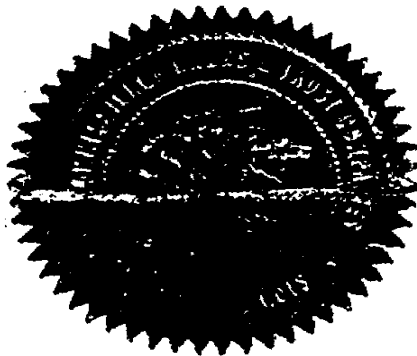
### CONVERSION CERTIFICATE

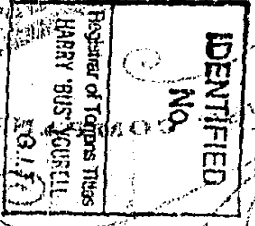
