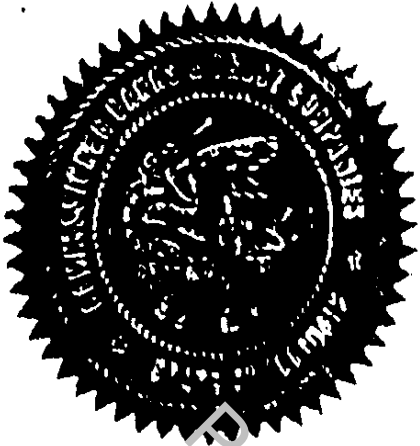

I hereby certify that at a meeting of the Board of Directors of the Main Bank, at the offices of the Cole-Taylor Financial Group, Inc., Northbrook, Ill., located at 350 E. Dundee Rd., Wheeling, Illinois, held on the 22nd day of January

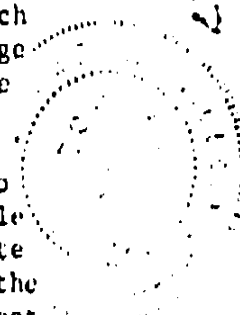
a newspaper printed in the City of Chicago County of Cook, State of





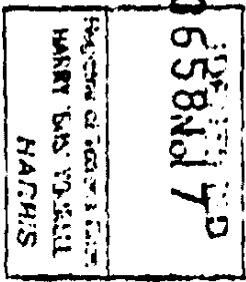
