The failure of the Moringee to exercise any right which it might exercise he outder shall not be deemed a waiver by the Mortgage of its right of exercise therea ter.

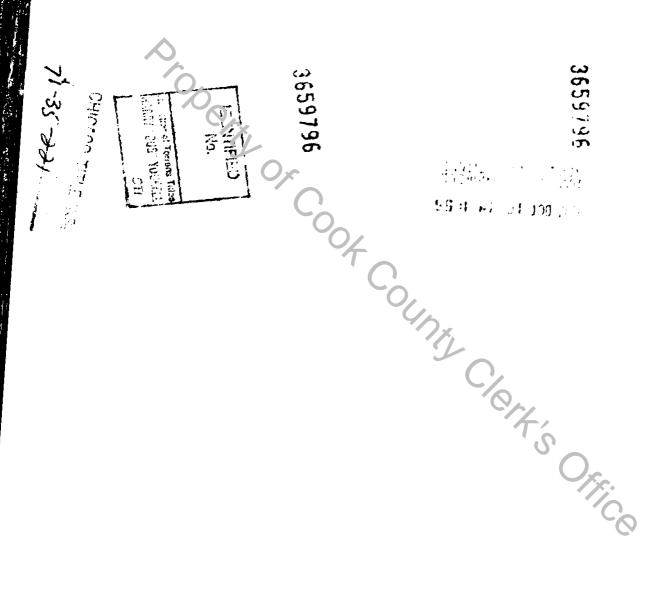
