East of the Third Principal Meridian.

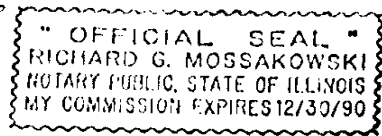

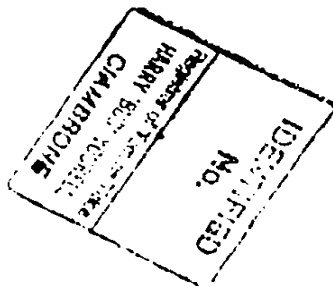
