JUDGMENT FOR DISSOLUTION OF MARRIAGE

This cause coming on to be heard on the 7th day of October 1987 as a default hearing in the above-captioned petition for a Dissolution of Marriage, service by publication, there being a default date of 9/14/87, and the Petition being taken as confessed by the Respondent, with the Petitioner being represented by Attorney ROBERT L. RIEFF.

AND, the Court having heard the testimony of the Petitioner, taken in Open Court (a Certificate of which evidence is filed herein) and being fully advised in the premises, THE COURT FINDS:

1. That it has jurisdiction of the parties and the subject matter;
2. That the Petitioner at the time of filing said Petition was domiciled in the State of Illinois; and said domicile has been maintained in Cook County for 90 days continuously prior to the filing of the Petition herein;
3. That the parties were lawfully married on 9/17/49 in the city of Chicago, County of Cook, where it was registered, in the State of Illinois.
4. That four (4) children were born of this marriage, all are adults between the age of 19 to 30; and that the Petitioner is not presently pregnant.
5. That the ages of the Petitioner is 57; and that the age of the Respondent is 61.

9. That Respondent vacated the marital home at 3833 S. Home Avenue, Berwyn, Cook County, Illinois on or about February, 1986 without cause or provocation on the part of Petitioner and Respondent has since signed a Quit-Claim Deed, conveying all interest in the aforementioned Marital Home to Petitioner.

THEREFORE, by virtue of the statutes of the State of Illinois, and on Motion of said Attorney for Petitioner, it is the judgement of the Court and,

IT IS HEREBY ORDERED:

a) That the bonds of matrimony heretofore existing between the parties be dissolved, and a dissolution of the marriage is hereby granted to the parties.

b) That the wife, Petitioner, ANNE D'AGOSTINO is awarded the marital home at 3833 South Home Avenue, in Berwyn, County of Cook, State of Illinois.

c) That each party shall keep the personal property now in their possession.

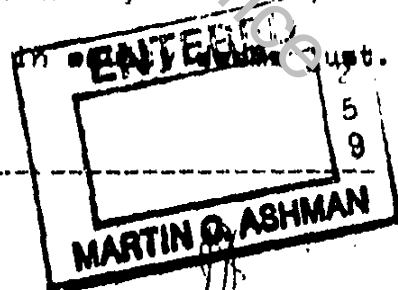
d) That Petitioner is hereby awarded the household furniture and furnishings.

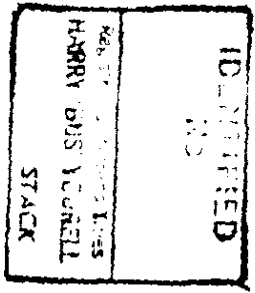
