First:

I direct my executor, hereinafter named, to pay all my just debts and obligations as soon after my decease as is practical.

Second:

I give, devise and bequeath all of my estate, real, personal and mixed, wherespever situate, unto my wife, Therese H. Perlinski.

Third:

In the event my said wife should predecease me, then and in such event I give, devise and bequeath all of my estate, real, personal and mixed, unto my children, Gregory A. Perlinski, Kathleen L. Perlinski, and Jerome J. Perlinski, share and share alike.

Fourth:

In the event any of my children predecease me, leaving issue surviving, then and in such event the share said predeceased child would have taken hereunder I give,

I neglinate, constitute and appoint my wife, Therese H.

Perlinski, to be the executor of this my Last Will and

Testament, to act without bond. In the event of the first death, disability or refusal of my said wife to so act,

then and in such event I nominate, constitute and appoint my son, Gregory A. Perlinski, to act as successor
executor, to act without bond. I grant unto both of the

aforesaid executors full power to sell any of my assets

in order to facilitate distribution of my estate.
