The undersigned, do hereby irrevocably appoint the Mortgagee the agent of the undersigned for the management of said property, and do hereby authorize the Mortgagee to let and re-let said premises or any part thereof, according to its own discretion, and to bring or defend any suits in connection with said premises in its own name or in the name(s) of the undersigned, as it may consider expedient, and to make such reports to the premises as it may deem proper or advisable, and to do anything in and about said premises that the undersigned might to hereby ratifying and confirming anything and everything that the Mortgagee may do.
