## LOAN MODIFICATION AGREEMENT

DUPLICATE IDENTIFIED

THIS AGREEMENT dated December 10, 1987 by and between the Harris Bank Hinsdale, National Association ("Mortgagee"); the Harris Bank Hinsdale, National Association as Trustee under Trust Agreement dated October 27, 1986 and known as Trust No. L-1402 ("Mortgagor"); and The Sedgley Development Group Partnership, J. Michael Meissner and William Swindle ("Guarantors"), witnesseth:

WHEREAS, Mortgagee has agreed to lend Mortgagor the principal amount of Six hundred Eighty Five Thousand and no/100 dollars (\$685,000.00) evidenced by a promissory note dated December 10, 1986, and secured by a Mortgage dated December 10, 1986, filed February 3, 1987, in the recorder's office of Cook County, Illinois as Document No. LR3588910, mortgaging, granting, and conveying to Mortgagee the property legally described as:

Tract 3 in Burr Ridge Estates, a Subdivision of part of the North West 1/4 of Section 19, Township 38 North, Range 12, East of the Third Principal Meridian, lying South of the Center Line of Plainfield Road in Cook County, Illinois according to the Plat thereof recorded May 2, 1950 as Document No. 14790705, in Book 382 of Plats, Page 22.

That part of the Vacated 67th Street lying South of and adjoining Tract 3 in Burr Ridge Estates, being a Subdivision of part of the North West 1/4 of Section 19, Township 38 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois, lying South of the Center Line of Plainfield Road, according to the Plat thereof recorded May 2, 1950 as Document 14790705 in Cook County, Illinois.

WHEREAS, said note is due and payable and the parties wish to extend the Maturity date of the note;

NOW, THEREFORE, the parties hereto agree to extend the Maturity date of the mortgage and note to December 10, 1988.

In all other respects, the parties hereto reconfirm and ratify the provisions of the mortgage, note, and construction loan agreement.

This Loan Modification Agreement is executed by the Harris Bank Hinsdale, National Association, not personally, but as Trustee as aforesaid in the exercise of the power and authority vested in it as such Trustee; and it is expressly understood and agreed that nothing contained herein or in said note and mortgage shall be construed as creating any liability on the Harris Bank Hinsdale, National Association as Trustee or on the Harris Bank Hinsdale, National Association personally to pay the said note or any interest that may accrue thereon, or any indebtedness accruing hereunder, or to perform any covenant either express or implied contained herein, all such liability, if any, being expressly waived by the
