AGREEMENT FOR ADDITIONAL ADVANCES ..

WHEREAS, the undersigned executed and delivered to the METRO-POLITAN BANK AND TRUST COMPANY, a note secured by a mortgage, trust deed, or other instrument to said Bank, or for its benefit, registered in the Office of the Registrar Titles of Cook County, 111inois, as Document No. LR3657902, dated the 22nd day of June, 1987, for an original sum of Four Hundred Fifty Thousand and 00/100 Dollars (\$450,000.00) which provides for additional advances to be secured by said instrument as a first lien; therefore, it is agreed that an additional advance shall be made upon the said note in the sum of Twenty Thousand and 00/100 Dollars (\$20,000.00) to be charged to said loan account known as Loan No. GP 299, 181-30-08-CHI upon the books of said Bank.
