Commonly known as 212 E. Nerge Road, Schaumburg, Illinois.



That said owners and their agents Voula Koulouris, Robert D. Gordon, and Spaulder Finance Company are entitled to no credits on account, leaving due, unpaid and owing to claimant, after allowing all lawful credits, the sum of \$8,200.00 for which with interest the claimant claims a lien on said land and improvements.
