That on MARCH 7, 1987, said contractor made a subcontract with the claimant to furnish masonry labor and materials for Knollgreen Industrial Center, Building C, Phase III using utility size face brick, standard size brick and natural colored mortar, including durawall reinforcement pilasters, setting of loose lintels, flashing, patching and brick cleaning for the sum of \$125,900.00, for and in said improvement, and that on JANUARY 30, 1988, the claimant completed thereunder all required by said contract to be done.

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ 316.00 and completed same on MAY 18, 1987.

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) ~~do not reside in said County.~~⁴

That said contractor is entitled to credits on account thereof as follows: \$119,500.00 paid on account

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Six Thousand Seven Hundred Sixteen and 00/100 (\$6,716.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
