Pursuant to petition of GEORGE L. BRUCKERT, JR., AS TRUSTEE UNDER

to withdraw land from registration, the undersigned Examiner of Titles hereby reports to Harry 'Bus' Yourell, Registrar of Titles, that he has determined as follows:

1. That as the time of the filing of the petition herein the said petitioner(s) (was/were) the owner(s) in fee simple of certain real estate in the County of Cook and State of Illinois, described in said petition, and as follows to wit:

That part of LOT EIGHT (8), lying West of a line extending across said lot, said line being a curve having a radius of 5604.58 feet, which curve intersects the East line of said lot at a point 28.79 feet North of the Southeast corner of said lot and whose tangent at the point of intersection with the East line of said lot forms an angle of 9 degrees 14 minutes 50 seconds in the Northwest quadrant of their intersection, said curve also intersecting the North line of said lot at a point 18.15 feet West of the Northeast corner of said lot and whose tangent at the point of intersection with the North line of said lot forms an angle of 100 degrees 20 minutes 16 seconds in the Northeast quadrant of the intersection.

That part of LOT TEN (10), lying West of a line extending across said lot, said line being a curve having a radius of 5604.58 feet, which curve intersects the North line of said lot at a point 63.88 feet West of the Northeast corner of said lot, and whose tangent at the point of intersection with the North line of said lot forms an angle of 102°44'16" in the Northeast quadrant of their intersection; said curve also intersecting the South line of said lot at a point 42.20 feet West of the Southeast corner of said lot, and whose tangent at point of intersection with the South line of said lot forms an angle of 101°42'47" in the Northeast quadrant of their intersection.

In Block Fifteen (15), in Highlands, said Highlands, being a Subdivision of the Northwest Quarter (4) and the West Eight-hundred (800) feet of the North One Hundred Forty Four (144) feet of the Southwest Quarter (4) of Section 7, Township 38 North, Range 12, East of the Third Principal Meridian.

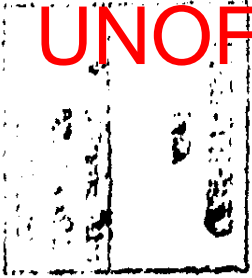
