NOW THERFFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSEMONT, COOK COUNTY, HALINGIS, IN THE EXERCISE OF ITS HOME PULE POWERS, as follows

SECTION 1: That Evenhouse Avenue as depicted on Exhibit A attached hereto and made a pact hereof be and the same is hereby vacated and closed inasmuch as sold exceet is not required for public use and the public interest will be best subserved by such vacation and the Village President, Clerk and Engineer are suthorized and directed to execute Exhibit A attached hereto and made a part hereof.

SECTION 2: This ordinance and each of its torus shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law; or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Rosement that to the extent that the terms of this ordinance should be inconsistent with any non-preemptive state law, that this ordinance should supersede state law in that regard within its jurisdiction.
