commonly known as 9526 Hacke Court, Franklin Park, Illinois.


2. That said real estate is registered in the Office of the Registrar of Torrens Titles for Cook County, Illinois as Certificate of Title No. 667976.

5. That on June 2, 1988, the attached Satisfaction of Mortgage was located in my personal records and belongings.



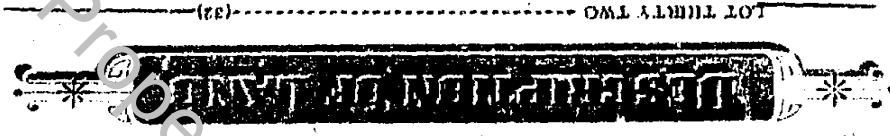
