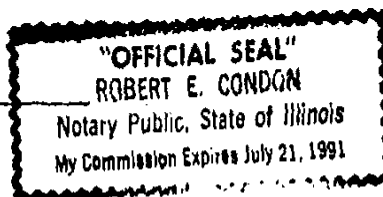

SEVENTH. Although my wife and I have executed Wills on or about the same date, we are not doing so pursuant to any contract between us or with any understanding or promise as to revocability.

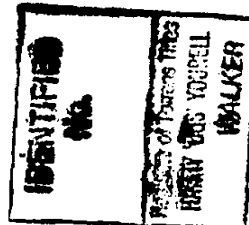
