in that on or about the 12th day of February, 1971, and again, on or about the 27th day of February, 1971, the defendant did strike, beat and hurt the plaintiff about her head, face, body and limbs, thereby bruising and injuring her and causing her great pain and suffering, and all without any reasonable cause or provocation on the part of the plaintiff toward him.

6. That as a result of the aforesaid conduct of the defendant, the plaintiff was compelled to cease living with the defendant as his wife, and that from February 27, 1971 to date hereof the plaintiff has lived separate and apart from defendant as a single person and without fault on her part.

7. That no children were born or adopted as a result of this marriage.

8. That the defendant is adjudged in default.

9. That the equities of the instant cause are with the plaintiff and that the allegations of her Complaint for Divorce have been proven.

IT IS, THEREFORE, HEREBY ORDERED, as follows:

(A) That the bonds of matrimony between the plaintiff, MARY E. BURNETT, and the defendant, MARION L. BURNETT, be and they are hereby dissolved, and the plaintiff is granted a Judgment of Divorce from the defendant.

(B) That the plaintiff is hereby granted leave to resume the legal and regular use of her maiden name, to-wit: MARY E.

(C) That both parties are forever barred from alimony,

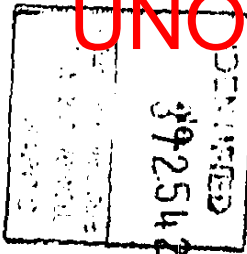
