That part of the Northwest Quarter (1) of Section 34, Township 41 North, Range 9, East of the Third Principal Meridian, described as follows: Beginning at Northwest corner of said Northwest Quarter (1) Section 34, Township 41 North, Range 9, East of the Third Principal Meridian, thence East on Section line 8 chains and 25 links; thence South 11 chains and 98 links; thence West 8 chains and 23 links; thence North 11 chains and 91 links to the place of beginning (except that part thereof described as follows: Commencing at the Northwest corner of said Section 34, for the point of beginning. Then South along the west line of said Section 34, for a distance of 517.1 feet to a point; thence Northeasterly along a curve to the left having a radius of 2810.95 feet and tangent to a line which forms an angle of 170 degrees, 34 minutes to the left with a prolongation of the last described course for a distance of 516.4 feet to a point; thence Northerly along a line tangent to the last described curve for a distance of 5.4 feet to a point on the North line of said Section 34; thence West along the North line of said Section 34, which forms an angle of 91 degrees, 47 minutes, to the left with a prolongation of the last described course for a distance of 37.5 feet more or less to the point of beginning.


