### JURISDICTION. Ox

- That it has jurisdiction of the parties hereto and the subject matter hereof.
- 2. The court specifically finds service of process in each instance was properly made.

Under the erms of the mortgage, all ach advances, costs, attorneys fees and other fees, expenses and disbursements are made a lien upon the mortgaged real estate and the plaintiff is entitled to recover all such advances, costs, attorneys fees, expenses and disbursements, together with interest on all advances at the rate of interest provided in the mortgage, from the date on which such advances are made.

- 4. In the event the plaintiff is a purchaser of the mortgaged real estate at such sale, the plaintiff may offset against the purchase price of such real estate the amount due under the judgment for foreclosure and order confirming the sale.
- 5. In the event of such sale, and the failure of the person entitled thereto to redeem prior to such sale, pursuant to statutory provisions, the defendants made parties to the foreclosure in accordance with statutory provisions, and all persons claiming by, through or under them, and each and any and all of them, shall be forever barred and foreclosed of any right, title, interest, claim, lien or right to redeem in and to the mortgaged real estate.
- 6. If no redemption is made prior to such sale, a deed shall be issued to the purchaser according to law and such purchaser shall be let into possession of the mortgaged real estates in accordance with statutory provisions.

### VI. ORDER UPON SPECIAL MATTERS.

Exceptions to which title shall be subject at the sale shall include general real estate taxes for past years, (if any) the current year, and for the preceding year which have not become due and payable as of the date of this judgment and any special assessments upon the real estate and easements and restrictions of record.
- 5. In the event any party to this foreclosure is a successful bidder at the sale, such party may offset against the purchase price to be paid for such real estate the amounts due such party under this judgment of foreclosure or the order confirming the sale.

### VII. ORDER FOR JUDICIAL SALE.

1. The real estate is ordered sold according to law.

- 2. Upon expartion of the tredemption proof the real estate shall be sold at a sale as provided by law.
- 3. NOTICE OF SALE: The mortgagee, or such other party designated by the court, in a foreclosure under this Article shall give public notice of the sale.
