COUNT II

As a second and further cause of action the plaintiff, City of Chicago, A Municipal Corporation:

- 1-5 Realleges the allegations of paragraphs one through five of Count I as paragraphs one through five or count II and further alleges:
- 6. That the levying of a fine is not an adequate remedy for the abatement of a nuisance, and that it is necessar, that a temporary and permanent injuction issue and a receiver be appointed to tring the subject property into compliance with the Municipal Code of Chicago.
- 7. That Raleigh Mathis, the Commissioner of Inspectional Services, City of Chicago, has determined said building to be dangerous and unsafe or uncompleted and abandoned.

WHEREFORE, PLAINTIFF PRAYS:

- a. For a temporary and permanent injunction requiring the detendants to correct the said violations and to restrain future violations permanently.
- b. For the appointment of receiver, if necessary, to correct the conditions alleged in the Complaint with the full powers of receivership including the right to issue and sell receivers certificates.
- c. For an order of the plaintiff to demolish said premises and a judgement against defendants and a lien of the subject property for the cost of demolition in accordance with Section 11-31-1 of Chapter 24 of the Illinois Revised Statutes, as amended, or for an order for plaintiff to demolish said premises under the police power to protect the public health and safety.
