TRUSTEE'S INDENTURE OF SUCCESSION IN TRUST

6/30/88

THIS INDENTURE made this 1 day of August, 1988, between THE BANK & TRUST COMPANY OF ARLINGTON HEIGHTS, an Illinois corporation, not personally but solely as Trustee under the provisions of a Deed in Trust, duly registered and delivered to said bank in pursuance of a trust agreement, dated the 18 day of April 1986, and known as Trust Number 3578, party of the first part, and

NBD TRUST COMPANY OF ILLINOIS, an Illinois corporation, as Successor Trustee under provisions of a trust agreement dated the 18 day of April 1986, and known as Trust Number 3578-AH, party of the second part.

WITNESSETH

That said party of the first part, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, does hereby convey and quitclaim unto said party of the second part, the real estate in Cook County, Illinois, described on Exhibit A hereto, together with the tenements and appurtenances thereunto belonging.

TO HAVE AND TO HOLD, unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part on the same trust terms as same has been held by the party of the first part with all of the powers and duties given in said Trust Agreement.

This indenture is executed pursuant to and in the exercise of the power and authority granted to and vested in the said party of the first part as Trustee in pursuance of the Trust Agreement above mentioned. This indenture is made subject to the lien of every trust deed or mortgage (if any there be) of record given to secure the payment of money, and remaining unrelaxed at the date of delivery hereof, and subject to all covenants and restrictions and conditions of record.

IN WITNESS WHEREOF, said party of the first part has caused its corporate seal to be hereto affixed, and has caused its name to be signed to these presents by its VICE PRESIDENT & TRUST OFFICER and attested to by its ASSISTANT VICE PRESIDENT & TRUST OFFICER the day and year first written above.

LEGAL DESCRIPTION

That part of lot 1 in "Arlington on the Ponds I", being a subdivision in the Northwest Quarter of Section 21, Township 41 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois, according to the plat thereof filed in the Office of the Registrar of Titles of Cook County, Illinois, on May 27, 1987, as Document No. LR-3620381, described as follows: Beginning at a point on the East line of said Lot 1 243.72 feet North of the Southeast corner of said lot 1; thence North 00 degrees 40 minutes 06 seconds West along said East line of said Lot 1 a distance of 716.04 feet; thence North 81 degrees 40 minutes 46 seconds West a distance of 128.35 feet; thence South 15 degrees 41 minutes 42 seconds West a distance of 78.31 feet to a point of curvature; thence along a curve to the left, tangent to the last described line, having a radius of 371.52 feet, an arc distance of 197.91 feet (the chord of which bears South 00 degrees 26 minutes 04 seconds West) to a point of tangency; thence tangent to the last described curve South 14 degrees 49 minutes 33 seconds East a distance of 39.95 feet to a point of curvature; thence along a curve to the right, tangent to the last described line, having a radius of 472.23 feet, an arc distance of 170.30 feet (the chord of which bears South 04 degrees 29 minutes 35 seconds East), to a point of reverse curvature; thence along said reverse curve to the left, having a radius of 753.04 feet, an arc distance of 147.79 feet (the chord of which bears South 00 degrees 13 minutes 03 seconds West) to a point of tangency; thence tangent to the last described curve South 05 degrees 24 minutes 18 seconds East a distance of 73.70 feet to a point of curvature; thence along a curve to the right, tangent to the last described line, having a radius of 123.60 feet, an arc distance of 36.91 feet (the chord of which bears South 03 degrees 08 minutes 53 seconds West) to a point; thence North 89 degrees 19 minutes 54 seconds East a distance of 130.16 feet to the point of beginning, excepting therefrom that part of lot 1 described as follows: Beginning at a point on the East line of said Lot 1, 797.60 feet North of the Southeast corner of said Lot 1; thence North 00 degrees 40 minutes 06 seconds West along said East line of Lot 1 a distance of 167.13 feet; thence North 81 degrees 40 minutes 46 seconds West a distance of 128.35 feet; thence South 15 degrees 41 minutes 42 seconds West a distance of 78.31 feet to a point of curvature; thence along a curve to the left, tangent to the last described line, having a radius of 371.52 feet, an arc distance of 87.64 feet (the chord of which bears South 08 degrees 56 minutes 13 seconds West); thence South 81 degrees 40 minutes 06 seconds East a distance of 165.45 feet to the point of beginning.




