To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now and hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the contract, under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies including additional and renewal policies to holder of the contract and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein. Mortgagee or the holder of the contract may, but need not, make any payment or perform any act hereinbefore required "of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, red purchase, discharge, compromise or settle any tax bien or other prior lien or little or claim thereof, or redeem from any tax sale or forfeiture, affecting bad premises or contest any tax or assessment. All moneys paid for any of these purposes helein authorized and all expenses paid or incurred in connection therewith, including attorneys fees, and any other moneys advanced by Mortgagee or the holders of the contract to protect the reorgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice. Inaction of Mortgagee or holders of the contract shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of the Mortgagors.
- 5. The Mortgagee or the holder the contract hereby secured making any payment hereby authorized relating to taxes and assessments, may do so according to any bill statement of the imate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any is a reseasment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall pay each item of the bitedness herein mentioned, when due according to the terms hereof. At the option of the holder of the contract, and without notice to the Mortgagors, all unpaid indebtedness secured by the Mortgage shall, notwithstanding anything in the contract or in this Mortgage to the contrary, become due and payable is immediately in the case of default in making payment of any instalment on the contract, or (b) when default shall occur and continue to the contract. - 7. When the indebtedness bereby secured shall be long due whether by acceleration or otherwise. Mortgages shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or included by or on behalf of Mortgages or holder of the contract for attorneys less, appraiser's fees, outlays for documentary and expert evidence, stenograph in the larges, publication costs and costs which may be estimated as to items to be expended after entry of the decreed of procuring all such abstracts of the larges, publication costs and costs which may be estimated as to items to be expended after entry of the decreed of procuring all such abstracts of the earthest and examinations, guarantee policies. Torrens certificates and similar data and assurances with respect to title as Mortgages or holder of the contract may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expenses of the nature in this paragraph mentioned shall be rome so much additional indebtedness secured hereby and immediately due and payable, when paid or incurred by Mortgages or holder of the contract in connection with (a) any proceeding, including probate and bankupter proceedings, to which either of them shall be a party, either as plaintif, clai nant or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparations for the commencement of any suit for the inreclosure hereof after accural of such right to foreclose whether or not actually commenced or (c) preparations for the defense of any threatened suit or proceeding which might affect the premises or the accurity hereof whether or not actually commenced.
- 8. The proceeds of any foreclosure sele of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such flem, at are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additions for that evidenced by the contract, third, all other indebtedness, if any, remaining unpaid on the contract: fourth, any overplus to Mortgagors, their vel/s legal representatives or assigns as their rights may appear.
- 9. Upon, or at any time after the filing of a bill to foreclose this mortgage the court in which Build is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale without notice, without regard to the following or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Mortgagee hereundermay be appointed as such receiver. Such receiver shall have power to object the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency during the full structurery period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver. Sould be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the profection, possession, control management and operation of the premises during the whole of said period. The Court from time to time may author at the receiver to apply the net income in his hands in payment in whole or in part of: (1) The indebtedness accurred hereby, or by any decree foreclosing this it fortgage or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application, is made prior to foreclosure sale; (2) the deficiency.

If Mortgagors shall sell, assign or transfer any right, title or interest in said premises, or any portion thereof, without the written consent of the holder of the contract secured hereby, holder shall have the right, at holder's option, to declare all unpaid indebtedness secured by this mortgage to be immediately due and payable, anything in said contract or this mortgage to the contrary notwithstanding.
