includes all costs of collection, legal expenses, and attorneys' and paralegals' fees, incurred or paid by Assignee in attempting the collection or enforcement of any of the Liabilities of the undersigned and/or Medical or any guarantor of the undersigned and/or Medical. Liabilities includes all of the indebtedness or contractual duties of partnerships to Assignee created or arising while the undersigned and/or Medical or any guarantor of the undersigned and/or Medical may have been or may be a member of those partnerships.
