LEGAL DESCRIPTION RIDER

Parcel 1: Unit Number S-49, as delineated in surveys of the following described parcels of real estate (hereinafter together referred to as "parcel"): Lots 2 and 3 in Sigwalt's Subdivision of the North 1/2 of the West 15 acres of the North 30 acres of the West 1/2 of ten Northwest 1/4 of Section 32, Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 2: The South 2 chains of the North 4.25 chains of the West 2.5 chains of the West 10 chains of the West 1/2 of the Northwest 1/4 of Section 32, Township 42 North, Range 11, East of the Third Principal Meridian, which surveys are attached as Exhibit "A" to the Declaration made by the LaSalle National Bank, a national banking association, not personally, but as Trustee under Trust No. 39135 recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document Number 2463600 and registered in the Office of the Registrar of Titles of Cook County, Illinois, as Document Number X 2586495; together with an undivided 2.6 percent interest in said parcel (except from said parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and surveys); together with an exclusive easement for parking purposes in and to parking space number S-49 as defined and delineated in said Declaration and surveys, all in Cook County, Illinois.
