

No provision of this Assignment of Rents shall be deemed to affect or impair any rights which Assignee may have under any other instrument which secures or is delivered in connection with the Liabilities.



- (a) Operating expenses of the Premises, including but not limited to the cust of management and leasing of the Premises; reasonable compensation to Assignee and Assignee's management agent or agents, if applicable, leave commissions and other compensation and expenses of seeking and pursuing tonants and entering into leasts, reserves for claims for damages, if any, premiums on insucance policies as authorized by this Assignment of Rents and all anterneys' fees, paralegals' fees and costs incurred in management and leasing of the Premises;
- (b) Taxes and special assessments now dise or which may hereafter become due on the Premises;
- (c) All repairs, decorating, renewals, replacements, alterations, additions or improvements of the Premiser, including the cost from time to time of installing or replacing refrigeration, gas or electric appliances on the Premises, and or placing the Premises in such condition as will, in the judgment of Assignee, make the Premises readily rentable; and
- (d) Any Liabilities (first to interest and then to principal).

The undersigned does further specifically authorize and instruct each and every present and future lessee or tenant of all or any part of the Premises to pay to Assignee immediately upon demand by Assignee all rents which the undersigned and such lessee or tenant agreed would be unpaid.


