Biedermann, a Registered Illinois Land Surveyor, do hereby certify that I am the same person who signed as surveyor the Plat of Subdivision known as Shiner's Subdivision, being a resubdivision of part of Lots 5 and 6 in the Subdivision of Joseph A. Barnes' Farm in Sections 9, 15 and 16, Township 41 North, Range 11, East of the Third Principal Meridian, recorded as document #88155953, in Cook County, Illinois, and I further certify that the 1st paragraph of the Dedication certificate reads as follows:

We, the undersigned, American National Bank & Trust Company of Chicago U/T/A 67571, owners of the real estate shown and described herein, do hereby lay off, plat and subdivide said real estate in accordance with the within plat. This subdivision shall be known and designated as Shiner's Subdivision, an addition to the Village of Arlington Heights, Cook County, all streets and alleys and public open spaces shown and not heretofore dedicated are hereby dedicated to the public. Front and side yard building setback lines are hereby established as shown on this plat, between which lines and the property lines of the streets, there shall be erected or maintained no building or structure. There are strips of ground, _____ feet in width, as shown on this plat and marked "easement" reserved for the use of public utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easement herein reserved. No permanent or other structures are to be erected or maintained upon said strips of land, but owners of lots in this subdivision shall take their titles subject to the rights of the public utilities, and to the rights of the owners of other lots in this subdivision.

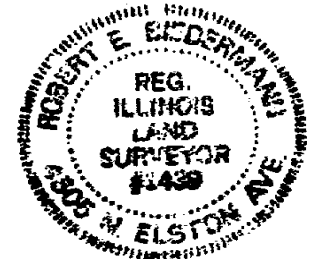
