JUDGMENT FOR DISSOLUTION OF MARRIAGE

THIS CAUSE, COMING TO BE HEARD ON THE PETITION FOR DISSOLUTION OF MARRIAGE BEFORE THE HONORABLE JUDGE HYMAN FELDMAN ON MAY 18, 1938. THE PETITIONER AND HER ATTORNEY, ADAM A. DABEK, PRESENT IN COURT, THE RESPONDENT HAVING BEEN DEFAULTED, AND THE COURT MAVING HEARD, THE EVIDENCE PRESENTED BY THE PETITIONER;

#### FINDS:

- 1. THAT THE COURT HAS PERSONAL JURISDICTION OVER THE PARTIES AND SUBJECT MATTER JURISDICTION
- 2. THAT THE PETITIONER IS AND HAS BLEY A RESIDENT OF AND DOMICILED IN THE COUNTY OF COOK, STATE OF LLILINGIS, FOR MORE THAN 90 DAYS PRECEDING THE FILING OF THIS PETITION.
- 3. THAT THE PARTIES WERE MARRIED IN BIALOSTOK POLAND ON SEPTEMBER 13, 1969, AND THAT THE MARRIAGE IS REGISTERED IN BIALOSTOK, POLAND.
  - 4. THAT ONE CHILD WAS BORN TO THE MARRIAGE; AGNIESZKA MACZEK BORN 12-13-1971.
- 5. THAT NO OTHER CHILDREN WERE BORN TO OR ADOPTED DURING THE COURSE OF THE MARRIAGE. AND THE PETITIONER IS NOT NOW PREGNANT.
- 6. THAT THE PETITIONER IS A FIT AND PROPER PARENT TO HAVE THE PERMANENT CARE, CUSTODY AND CONTAGE OF THE CHILD.
- 7. THAT BOTH THE PETITIONER AND RESPONDENT ARE CURRENTLY EMPLOYED, AND THE RESPONDENT EARNS A NET AMOUNT OF ONE THOUSAND FOUR HUNDRED SIXTY NINE DOLLARS AND EIGHTY CENTS PER MONTH. (\$1469.80).



THAT THE PETITIONER CURRENTLY HAS SOLE AND EXCLUSIVE

AND THAT THE COURT SHOULD AWARD THE PETITIONER THE NORTHWESTERN CANK ACCOUNT, AWARD THE RESPONDE THE PLAZA BANK ACCOUNT, AND THAT THE CRAGIN BANK ACCOUNT BE DIVIDED BETWEEN THE PARTIES EQUALLY.

- 10. THAT THERE ARE TWO AUTOMOBILES, AND THAT THE COURT AWARD THE 1984 FORD GTD TO THE RESPONDENT, AND AWARD THE 1983 CHEVY CITATION TO THE PETITIONER.
  - 11. THAT BOTH PARTIES WAIVE MAINTENANCE.
- 12. THAT WITHOUT CAUSE OR PROVOCATION ON THE PART OF THE PETITIONER, THE RESPONDENT FAS BEEN GUILTY OF REPEATED MENTAL CRUELTY TOWARD THE FETITIONER WITHIN THE MEANING AND PURVIEN OF PARAGRAPH 2, SECTION 401. OF THE ILLINOIS MARRIAGE AND DISSOLUTION OF MARRIAGE ACT.
- 13. THAT THE PETITIONER WILL BE SOLELY RESPONSIBLE FOR MAKING THE MORTGAGE PAYMENTS ON THE MARTAL HOME.

THEREFORE, BY VIRTUE OF THE STATUTES OF THE STATE OF ILLINOIS, AND ON THE MOTION OF THE PETITIONER, IT IS THE JUDGMENT OF THIS COURT, AND IT IS HEREBY ORDERED;

- A. THAT THE BONDS OF MATRIMONY HERETOFORE EXISTING BETWEEN THE PETITIONER AND THE RESPONDENT BE DISSOLVED AND THE MARRIAGE IS ACCORDINGLY DISSOLVED AS TO BOTH PARTIES.

- C. THAT THE RESPONDENT IS ORDERED TO PAY TO THE PETITIONER. THE AMOUNT OF TWO HUNDRED AND NINETY FOUR DOLLARS, (\$294.00) PER MONTH IN THE FORM OF CHILD SUPPOPT.
- D. THE PETITIONER IS AWARDED THE BANK ACCOUNT LOCATED AT THE NORTHWESTERN BANK, THE RESPONDENT IS AWARDED THE BANK ACCOUNT LOCATED AT THE PLAZA BANK, AND THE REMAINING BANK ACCOUNT LOCATED AT THE CRAGIN BANK CONTAINING \$2000.00 IS TO BE DIVIDED EQUALLY BETWEEN THE PETITIONER AND THE PESPONDENT.
