AFFIDAVIT

2. The deed granting my wife and me title to the property in question was registered with the Torrens Office on August 3, 1987, as Document Number 3640014. That deed incorrectly shows my name as "Donald D. Rouse" rather than Donald N. Rouse. However, my wife and I were the purchasers of the property in question, and we became the joint owners of that property by virtue of the deed in question.

3. Now, therefore, I, and my successors, shall at all times, indemnify and save harmless the Registrar of Titles, Cook County, Illinois, against all loss or damage to same, arising by reason of the incorrect statement of my name as "Donald D. Rouse" on the deed described above, and/or other title documents relating to 1090 Stonington Court, Schaumburg, Illinois, and the registering of same on

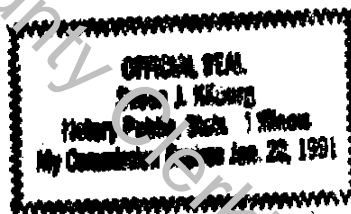
