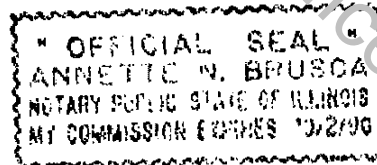

The Commission on the Judicial Branch of the State of Illinois was organized by Senate Bill 1000, which was passed by the Senate on June 17, 1969, and by the House of Representatives on July 1, 1969. The Commission was directed to study the organization, administration, and operation of the judicial branch of the State of Illinois and to report thereon to the Senate and the House of Representatives.

The Commission has the honor to submit to you this report on the work of the Commission during the year 1971. The Commission has held numerous public hearings and has received many suggestions from the public. The Commission has also conducted extensive research into the problems of the judicial branch of the State of Illinois.

The Commission believes that the judicial branch of the State of Illinois is facing a number of serious problems. These problems include the delay in the trial of cases, the expense of litigation, and the complexity of legal procedure. The Commission believes that these problems can be solved by the adoption of certain reforms.

The Commission recommends that the following reforms be adopted:

1. The creation of a judicial council to oversee the administration of the judicial branch.
2. The creation of a judicial budget to control the expenses of the judicial branch.
3. The creation of a judicial committee to study the organization and operation of the courts.
4. The creation of a judicial council to oversee the administration of the judicial branch.
5. The creation of a judicial budget to control the expenses of the judicial branch.
6. The creation of a judicial committee to study the organization and operation of the courts.

The Commission believes that these reforms are essential for the improvement of the judicial branch of the State of Illinois. The Commission urges the Senate and the House of Representatives to take prompt action on these recommendations.
