ORDER AUTHORIZING WITHDRAWAL OF COMPENSATION FUNDS

This matter coming before the court on the Notion of Defendant, State National Eark of Evanston, as Trustee U/T/A number 7685, for an Order authorizing the withdrawal of compensation funds by the Defendant from the Cook County Treasurer's Office in the amount of \$14,031.00, pursuant to the Judgment And Finding of Just Compensation by this Court dated September 29, 1988, and the Court being duly advised in the premises.

IT IS HEREBY ORDERED:

1. The Motion To Withdraw Compensation Funds from the Cook County Treasurer's Office is proper and is allowed for the taking of Tract 18-12 on Hintz Road which property is legally described as follows:
