



JUDGMENT FOR DISSOLUTION OF MARRIAGE

THIS CAUSE coming on to be heard on the Petition for Dissolution of Marriage of the Petitioner, RAYMOND STEWART; the Respondent having entered her Appearance; the Petitioner, appearing in open Court by his own person and by TOPPER AND WEISS, LTD., his attorneys, and Respondent appearing by her attorney, MURIEL G. FARMER; and the Court having heard the testimony of witnesses duly sworn in open Court; and the Court having heard the arguments of counsel, and being fully advised in the premises:

DOES FIND:

1. That it has jurisdiction of the parties hereto and the subject matter.
2. That one of the parties at the time of filing of said Petition was domiciled in the State of Illinois, and said

domicile has been maintained for ninety (90) days prior to the findings herein.

3. That the Petitioner has resided in Illinois for 38 years.

4. That the parties were lawfully joined in marriage on December 13, 1980, and said marriage is registered in Cook County, Illinois.

5. That no child was born to the parties as a result of this marriage. No children were adopted by the parties and, ^{Re. Child} the Petitioner is not expecting birth of a child at this time.

6. That the Petitioner is employed as a Facilities Manager.

7. That Respondent is domiciled in the State of Illinois and presently employed as a Unit Manager.

8. That the Respondent has been guilty of extreme and repeated acts of mental cruelty.

9. That the parties have entered into a proposed Oral Settlement Agreement, which the parties submit to the Court for approval, the sum and substance of which is as follows:

A. The parties each mutually agree to waive any right or claim to maintenance as against the other, past, present, or future, and agree to be barred from ever seeking maintenance against the other.

B. The parties agree that all other personal property has already been equitably divided to the satisfaction of the parties, and each shall have sole title and ownership of the personal property presently in their respective possession.

C. The Respondent shall be entitled to the 1986 Oldsmobile Delta 98 and her sole and exclusive property, and the Petitioner shall be entitled to his 1983 Lincoln Mark VI as his sole and exclusive property. Each of the parties shall be responsible for the respective liens and encumbrances against their respective vehicles.

D. That the Petitioner shall quit claim any and all interest he has in the marital residence to the Respondent, and that Respondent shall hold Petitioner harmless and indemnified for the mortgage, taxes, insurance, and utilities incurred for said residence. A copy of the legal description of said residence is attached hereto as Exhibit "A".

E. That the Petitioner shall pay to Respondent's attorney, MURIEL O. FARMER, the sum of \$400.00 representing Respondent's attorneys fees, as follows:

1. one-third (1/3) within 30 days of the entry of this Judgment;
2. one-third (1/3) within 60 days of said date;
3. one-third (1/3) within 90 days of said date.

F. Each party shall be responsible for their own debts and obligations incurred after the date of entry of the Judgment for Dissolution of Marriage.

G. That both Petitioner and Respondent waive any and all interest in each others pension and/or profit sharing with their respective employers and agree to sign any releases or other documents pertaining thereto.

1. That both Petitioner and Respondent agree to execute any and all documents, releases, etc. which are required to enforce consummate, or effectuate this oral settlement agreement upon request by either party.

I. That the Petitioner is entitled to the Pool Table located at the marital residence.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

A. The Petition for Dissolution of Marriage filed herein by Petitioner, RAYMOND STEWART, is granted and the parties are awarded a Judgment of Dissolution of Marriage; that the marriage heretofore existing between the parties be and it is hereby dissolved.

B. That the Oral Settlement Agreement entered into by the parties shall be and is hereby expressly made a part of this Judgment.

C. This Court expressly retains jurisdiction of this cause for the purpose of enforcing all the terms of this Judgment and for consideration of reserved matters.
