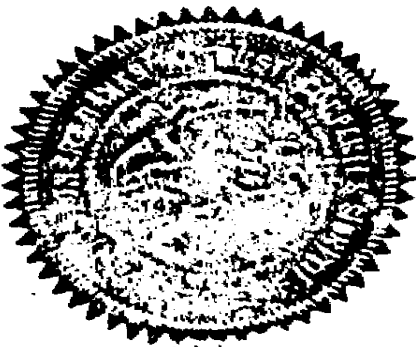

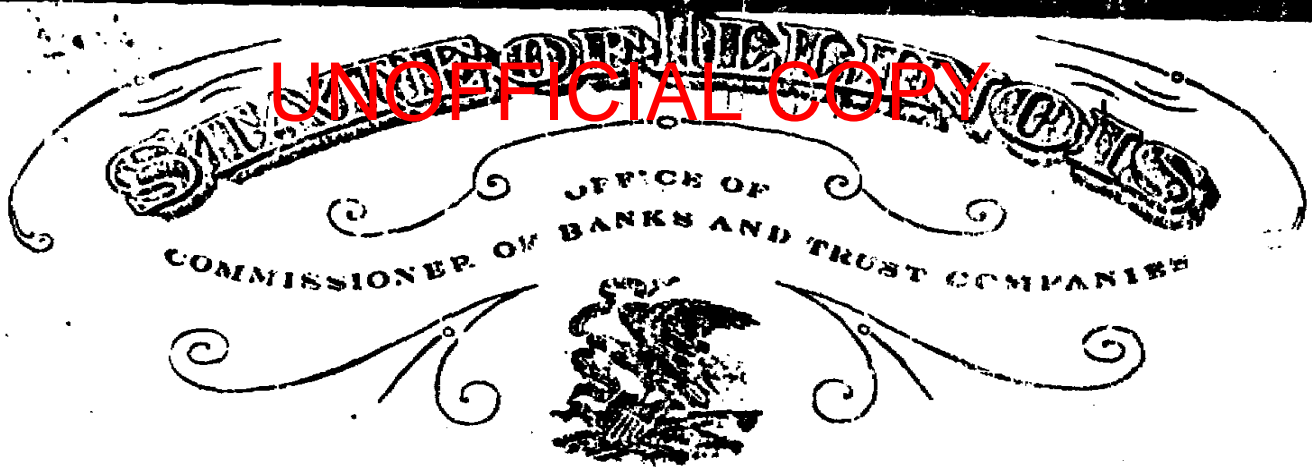

I hereby certify that there has been filed with me under the provisions of Section 43 of an act of the General Assembly of the State of Illinois known as the "Illinois Banking Act", approved May 11, 1955, in force January 1, 1957, a consent and approval executed by the shareholders of the Pioneer Trust & Savings Bank, located at 4000 West North Avenue, Chicago, Illinois, consenting to and approving the following amendment to the charter of the aforesaid bank:

WHEREAS, the Board of Directors of this Bank at a regular meeting duly held on the 18th day of April, 1975 at the office of the Bank, Chicago, Illinois, adopted and approved by resolution of said Board an amendment to the charter changing the name of the Bank from Pioneer Trust & Savings Bank to Pioneer Bank & Trust Company.

Dated this 16th day of May, 1975 and executed by the undersigned shareholders being all of the shareholders of the Pioneer Trust & Savings Bank.

I further certify that the capital stock of said bank is divided into 120,000 shares of \$5.00 par value each, and that the owners of record of 120,000 shares executed aforesaid consent and approval and that same is a part of the corporate record of the aforesaid bank.

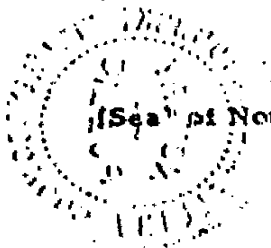

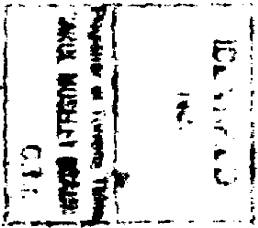
