Mortgagor covenants that Mortgagor is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Prewises, that the Premises is unencumbered unless otherwise acceptable to Mortgages and the Mortgagor will warrent and defend generally the title to the Premises against all claims and domands.

IT IS FURTHER UNDERSTOOD THAT:

- 1. Mortgagor shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, and late charges as provided in the Note, and the principal of and interest on any future advances secured by this Mortgage.
 - In addition, Mortgagor shall:
- (a) Promptly repair, restore or rebuild any improvement now or hereafter on the Premises which may become damaged or destroyed.
- (b) Pay immediately when due and payable all general taxes, special taxes, special assessment, water charges, sever service charges and other taxes and charges against the Premises, including those heretofore due, (the monthly payments provided in the Note in anticipation of such taxes and charges are to be applied thereto provided said payments are actually made under the terms of said Note), and to furnish the Montgages, upon request, with the original or duplicate receipts therefor, and all such items extended said Premises shall be conclusively deemed valid for the purposes of this requirement.
- (c) Keep the improvements now existing or hereafter erected on the Premises insured against loss or dauage by fire, lightning, wind storm or such other hazards, as the Mortgagee may reasonably require to be insured against under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or

repairing the same or to pay in full the indebtedness securedheraby, in such companies through such agents or brokers and in such form as shall be satisfactory to the Mortgages, until said indebtedness is fully paid, or in the case of foreclosure, until expiration of the period of redemption; such insurance policies, including additional and renewal policies shall be delivered to and kept by the Mortgages and shall contain a clause satisfactory to the Mortgages making them payable to the Mortgages, as its interest may appear, and in case of loss under much policies, the Mortgagee is authorized to adjust, collect and compromise, in its discretion, sign upon demand, all receipts, vouchers and releases required of it by the insurance companies; application by the Mortgages of any of the proceeds of such insurance to the indebtedness hereby secured shall not excuse the Mortgagor from making all monthly payments until the indebtedness is paid in full. All renewal policies shall be delivared at least 10 days bufore such insurance shall expire. All policies hall provide further that the Mortgages shall receive 10 days notice prior to cancelladion.

- (d) Complete within a reasonable time any buildings or improvements now or at any time in process of erection upon said property.
- (e) Keep said Premises 11 good condition and repair without waste and free from any mechanics or ther lies or claim of lies not expressly subordinated to the lies hereof.
- (f) Not suffer or permit any unlawful use of or any nuisants to exist on said Premises nor to diminish nor impair its value by any act or omission to act.

(g) Comply with all requirements of law or municipal ordinances with respect to the Premises and the use thereof.

- (h) Comply with the provisions of any least if this Mortgage is on a leasahold.
- (i) Pay the premiums for any life, disability or other insurance if Mortgagor shall produce contracts of insurance upon his life and disability insurance making the Mortgages assigned thereunder. In such event and upon failure of Mortgagor to pay the aforesaid premiums, the Mortgages may pay the premiums for such insurance and add said payments to the principal indebtedness recured by this Mortgage to be repaid in the same manner and without changing the amount of the monthly payments, unless such change is by mutual consent.

All of the agreements, conditions, covenants, provisions and stipulations contained in said Note which are to be kept and performed by Mortgagor are hereby wide a part of this Mortgage to the Name extent and with the same force and effect as if they were fully set forth herein, and Mortgagor covenants and agrees to keep and perform them or cause them to be kept and performed strictly in accordance with their terms.
- 9. In the event the enactment or expiration of any tederal or state laws which have the effect of rendering any provision of the Note or Mortgage unenforceable according to its terms, Mortgages, at its option, may declare, without notice, all sums accured hereby immediately due and payable, and apply toward the payment of said mortgage indebtedness any moneys of the Mortgagor held by Mortgages, and the said Mortgages may also immediately proceed to foreclose this Mortgage, as provided in Paragraphs 5 and 6 hereof.
- 10. Any forebearance by the Mortgagee in exercising any right or remedy hereunder or otherwise afforded by applicable

law, shall not be a waiver of or preclude the exercise of any such right or remedy. The procurement of insurance or the payment of taxes or other liens or charges by the Mortgages shall not be a waiver of the Mortgages's right to accelerate the indebtedness secured by this Mortgage.
