This Assignment of Lease and Rents is made by Armend 8. Donian and Yerna D. Bessian. As Trustees under the provisions of a Trust Agreement dated July 29. 1976, to further secure an indebtedness in the principal amount of \$150.000.00 evidenced by a promissory note dated June 9. 1989, made by the undersigned, secured by a mortgage of even date herewith, mortgaging to Cole Taylor Bank (the Bank) the real estate legality described in Exhibit A attached hereto and made a profilement and located in Gook County, Illinois.

In order to further secure the aforementioned indebtedness, and as part of the consideration of said transaction, the undersigned hereby assign, transfer, and set over unto said Bank, and/or its successors and assigns, all the rents now due or which may hereafter become due under or by virtue of any lease, either over or written, or any leating of, or any agreement for the use or occupancy of any part of the premises herein described, which may have been heretofore or may be hereafter made or agreed to, or which may be made or agreed to by the Bank under the power herein granted, it being the intention hereby to establish an absolute transfer and assignment of all such leases and agreements and all the avails hereunder unto the Bank and aspecially those certain leases and agreements now existing upon the property here namewe described.

The undersigned hereby irrevocably appoint the said Bank the Agent of the undersigned for the management of said property, and do lareby authorize the Bank to let and re-let said premises or any part thereof, according to its own discretion and to bring or defend any suits in connection with said pramises in its own name or in the name of any of the undersigned, as it may consider expedient, and to make such repairs to the premises as it may deem proper or advisable, and to do anything in and about said premises that the undersigned might do, hereby satisfying and confirming anything and averything that the said Bank may do.

It is understood and agreed that the small bank shall have the power to use and apply said avails, issues and profits toward the payment of any present or future indebtedness or liability of the undersigned up the small bank, the process of the contracted, and the toward the payment of all expenses for the care and management of said premises, including taxes, insurance, assessments, usual and customary commissions to a real estate broker for leasing said promises and collecting rents and the expense for such attorneys, agents and servants as may reasonably be necessary.

It is under tood and agreed that the Bank will not exercise its rights under this Assignment until after default (including the expiration of any applicable grace period) in any payment secured by the mortgage or after a breach of any of its covenants.
