It is understood and agreed that the Association may use and apply such available means and profits toward the payment of any present or future indebtedness or liability of the undersigned to the Association due or to become due, or that may hereafter be contracted, and also toward the payment of all expenses of the collection and enforcement of the premises, including attorney's fees, commissions and insurance premiums which may in its judgment be necessary and adequate, and the amount and character of any contribution that the Association may do by virtue hereof. This agreement shall be binding upon and shall be to the benefit of the heirs, executors, administrators, successors and assigns of the parties hereunto and shall be construed as a covenant running with the land and shall continue in full force and effect until all of the indebtedness or liability of the undersigned to the Association shall be fully paid, at which time this agreement shall terminate.

The failure of the Association to exercise any right which it might exercise hereunder shall not be deemed a waiver by the Association of the right of exercise thereafter.

THIS ASSIGNMENT is executed by the undersigned, James, not personally but as Trustee under the terms of the Cleresand Trust Agreement, and it is expressly understood and agreed by the parties hereto, anything to the contrary notwithstanding, that such and all of the covenants, undertakings and agreements herein made are made and intended, not as personal covenants, undertakings and agreements of the Trustee in its individual corporate capacity, but an covenant, undertakings and agreements of the Trustee acting solely in the exercise of the powers conferred upon it as such Trustee, and no personal liability or personal responsibility is assumed by, nor shall at any time be asserted or enforced against the Trustee in its individual corporate capacity, or against any agent or employee of the said Trustee, or anyone of them, on account of any covenant, undertaking or agreement herein contained, either expressed or implied, with such personal liability, or any, being hereby expressly waived and released by the parties hereto or holder hereof, and by my just and true changing by or through or under said parties or holders; and any of said parties or holders shall look solely to the real estate herein described, and the rents, issues and profits thereof or therefrom.
