PLAN OF ORGANIZATION

Lyons Savings, a Federal Savings and Loan Association, Countryside, Illinois

A. The association shall be called Lyons Savings, a Federal Savings and Loan Association ("New Federal").

B. New Federal shall be issued a Charter in the form of a Federal mutual savings and loan association charter in the form attached hereto as Exhibit A and shall adopt bylaws in the form attached hereto as Exhibit B.

C. Following the appointment of the Federal Savings and Loan Insurance Corporation ("FSLIC") as Receiver for Lyons Federal Trust and Savings Bank, Countryside, Illinois ("Association"), pursuant to § 5(d)(6)(A) of the Home Owners' Loan Act of 1933, as amended ("HOLA"), 12 U.S.C. § 1464(d)(6)(A) (1982), New Federal shall enter into an Acquisition Agreement with the FSLIC as Receiver for the Association for the purchase of substantially all of the Association's assets and the assumption of substantially all of the Association's liabilities (a copy of which Agreement is or shall be attached as Exhibit C).

D. On a copy of this Plan of Organization, a duly authorized officer of New Federal or representative of the FSLIC shall enter the date and local time of completion of all the previously described steps of organization in the space provided below and shall sign in the space provided below to certify such completion.

E. Except as the Federal Home Loan Bank Board ("Bank Board") otherwise provides by resolution, the organization of New Federal is complete when all of the actions described above in paragraphs A through D shall have been taken.

F. The board of directors of New Federal shall consist of individuals, all of whom are citizens of the United States and persons of good character and responsibility, as named by the Bank Board or Director or a Deputy Director of the Office of the FSLIC in Exhibit D (a copy of which Exhibit is or shall be attached).

G. New Federal shall execute a Special Agreement, an Agreement for Operating Policies, Application for Insurance of Accounts, and Application for Membership and Subscription to Stock in the Federal Home Loan Bank of Chicago (copies of which are or shall be attached as Exhibits E, F, G, and H, respectively), and New Federal's board of directors shall adopt the resolutions called for by the Application

The President and Secretary or other officer or person authorized to act for New Federal shall execute and submit to the Secretary or any Assistant Secretary of the Bank Board record copies of the Charter and Bylaws in accordance with the Resolution of the Bank Board authorizing the organization of New Federal.

for Insurance of Accounts and Application for Membership and Subscription to Stock in the Federal Home Loan Bank of Chicago and each director shall execute an "Oath of Director for FSLIC-Insured Institution" in the form attached as Exhibit I.

H. New Federal shall obtain blanket bond coverage, from a bonding company acceptable to the FSLIC according to the standards set forth in 12 C.F.R. § 571.14 (1987), in at least the amount specified in 12 C.F.R. § 563.19 (1987).

I. New Federal's home office shall be located at 450 West 35th Street, Countryside, Illinois 60402, and it shall operate branches at the locations which were previously branch offices of the Association, which locations are listed on Exhibit J (a copy of which Exhibit is attached).

J. New Federal's board of directors shall establish a fiscal year and determine a date for the annual meeting of New Federal's members.

K. New Federal shall serve the community previously served by the Association, and New Federal shall adopt and continue the Association's Community Reinvestment Act ("CRA") statement, delineation of community, and programs to implement its CRA policies.

L. New Federal shall initially continue the Association's savings and lending programs and shall offer accounts on the same basis and make loans on the same terms as the Association.
