WHEREAS, NATIONAL BANK OF AUSTIN, located at 5645 WEST LAKE STREET, in CHICAGO, County of COOK, State of Illinois, has filed with my office, the necessary documents as prescribed under the provisions of "An Act of the General Assembly of the State of Illinois, known as the Illinois Banking Act," approved May 11, 1955, in force January 1, 1956, and acts amendatory thereto;

AND WHEREAS, it appears that said bank has followed the procedure prescribed by the laws of the United States to convert into a state bank.

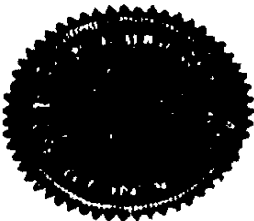
AND WHEREAS, it appears from the evidence furnished the Commission, as required by law that the capital stock of said bank, amounting to ONE MILLION EIGHT HUNDRED SEVENTY-FIVE THOUSAND DOLLARS consisting of ONE HUNDRED EIGHTY-SEVEN THOUSAND FIVE HUNDRED SHARES, of a par value of TEN DOLLARS each; the surplus amounting to ONE MILLION EIGHT HUNDRED SEVENTY-FIVE THOUSAND DOLLARS, and the operating reserves of said bank exceeds the statutory minimum requirements prescribed in Sections 7 and 26 of the Illinois Banking Act;

NOW THEREFORE, I, WILLIAM C. HARRIS, Commissioner of Banks and Trust Companies of the State of Illinois, by virtue of the power vested in me by the act aforesaid, do hereby approve the conversion of said bank to AUSTIN BANK OF CHICAGO, located at 5645 WEST LAKE STREET, in CHICAGO, County of COOK, State of Illinois, and authorize said bank to commence business as a bank under the provisions of the Illinois Banking Act for a term of TEN (10) years, unless sooner terminated by due process of law.

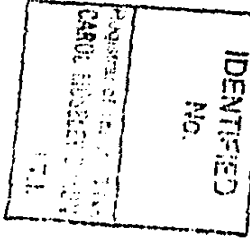
