Shell's waiver of any breach of this covenant shall not constitute a waiver of this covenant or or the subsequent breach hereof. This covenant shall run with the Burdened Premises, shall bind AL PAR, Inc.'s successors and assigns, and shall inure to the lenefit of Shell's successors and assigns.
