



BE IT FURTHER RESOLVED, that the Bank's charter be amended so. that the name of the Bank be changed from "Main Bank" to "Cole Taylor Bank/Main," and that all-action necessary to effectuate the same be taken. The actual timing of the name change of the Bank is within the discretion of the Bank's management, subject to the approval of the Charter Amendment by the Illinois Commissioner of Banks and Trust Companies.
