Office of the Registrar of Titles of Cook County, on January 9, 1975, as Document Number 2071382.

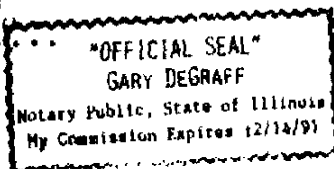
