 1. - 5. At such time as the Mortgagors are not in default either under the terms of the note secured hereby or under the terms of this mortgage, the Mortgagors shill have such privilege of making prepayments on the principal of said note (in addition to the required payments) as may be provided in said note.
- 6. Mortgagors shall kee, at Nildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm in her pulicies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the sit a vit to pay in full the indebtedness secured hereby, all in companies satisfactory to the Mortgagee, under insurance policies payable, in cise of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall be see all policies, including additional and renewal policies, to the Mortgagee, and in case of insurance about to expire, shall deliver recoval policies not less than ten days prior to the respective dates of expirition.
- 7. In case of default therein. Mortgage is ay but need not, make any payment or perform any act herembefore required of Mortgagors in any form and manner defined expedient, and may, but need not, make full of partial payments of principal or interestion pilit encuried brances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or confest any tax or assessment. All moneys, paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including altorneys fees, and any other moneys advanced by Mortgagee to prince the mortgaged premises and the lien hereof, half he so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest rate now permitted by Illinois law, function of Mortgagee shall never be considered as a waiver of any right account to a fortgage on account of any default hereunder on the part of the Mortgagors.
- 8. The Mortgagee making any payment hereby authorize relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or can methereof.
- 9. Mortgagors shatt pay each item of indebtedness berein nentioned, both principal and interest, when due according to the terms bereof. At the option of the Mortgage and without notice to Mortgage, all unpaid indebtedness secured by this mortgage shall, notwith-standing anything in the able or in this mortgage to the contrary, because they are payable (a) immediately in the case of default in making payment of any installment of principal or linetest on the note, or (b) when default shall occur and continue for three days in the performance of any other agreement of the Mortgagors berein contained.
- 10. When the indebtedness hereby secured shall become due whether by ac cleration or otherwise, Mortgagee shall have the right to forcefose the lien betoof. In any soil to forcefose the lien betoof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or more health of Mortgagee for attorneys fees, appraiser's fees, outlays for documentury and expenses which may be paid or incurred by or more health of Mortgagee for attorneys fees, appraiser's fees, outlays for documentury and expent evidence, stenographers' charges, patentation costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of tire, tile searches, and examinations, title insurance policies. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses modern to the foreclosure proceedings, including all such items as are usual as in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to duit evidenced by the note, with interest thereon as herein provided; third, all principal and interest remaining output on the note; four it any overplus to Mortagagors, their heirs, legal representatives or assigns, as their rights may appear.
- 12. Upon or at any time after the filing of a complaint to foreclose this mortgage the court in which such considint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not, and the Mortgagor may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises doring the pendency of such foreclosure stit and, in case of a sale and a deficiency, during the full standary period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to coffect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands his phynterial in whole or in part of: (1) The indebtedness secured hereby, or by any decree foreclosing this mortgage for any tax special, assessment other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.
- 13. No action for the enforcement of the lien or of any provision bereof shall be subject to any defense which would not be good and available to the party interposing same in an action at law upon the note bereby secured.
- 14. The Mortgagee shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.
- 15. If the payment of said indebtedness or any part thereof be extended or varied or if any part of the security he released, all persons now or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation or release.
- 16. Mortgagee shall release this mortgage and lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a reasonable fee to Mortgagee for the execution of such release.
- 17. This mortgage and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein and the holder or holders, from time to time, of the note secured hereby.
